

Understanding Status of Old Age Homes in India

In this manner, they are rendering an important contribution in promoting enrichment of their career prospects. The old age homes that account for 101 are meant exclusively for women. In Kerala, the old age homes are maximum in number that account for 124. Furthermore, there is a steady increase in the life expectancy of the individuals. Hence, there is prevalence of the viewpoint among Government and non-government organizations and senior citizens that establishment of old age homes will facilitate senior citizens in living a comfortable life. Furthermore, they will render an important contribution in promoting good health and well-being. Therefore, it is well-understood, old age homes enable senior citizens to live their lives with dignity and security.

A. Estimating Supply of Old Age Homes

The estimating supply of old age homes is taken into account in both urban and rural communities throughout the country. Furthermore, elderly family members get subjected to abuse and mistreatment. D. Inability to Manage Household Responsibilities

In some cases, the elderly family members are living alone. It is apparently understood that management of household responsibilities is indispensable, i.e., cleaning, washing, preparation of meals, painting, carpentry, plumbing, electric work, repair work and overall management of the households. When senior citizens are unable to manage the household responsibilities, they are required to obtain assistance from domestic helpers and service providers. When these individuals are not available, in such cases, it is difficult for senior citizens to manage all types of household responsibilities on an individual basis. As in most cases, they are not capable of carrying out manual tasks. Hence, they make the decisions in terms of transferring to old age homes. Therefore, it is understood on a comprehensive basis that inability to manage household responsibilities is a critical cause enabling senior citizens to live in old age homes

These are regarded as distressful conditions, which have unfavorable effects on health conditions of individuals, both physically as well as psychologically. As a consequence of living in old age homes, senior citizens are able to form an effective social circle. This is facilitating in augmenting information in terms of various subjects and concepts; exchanging different types of ideas and viewpoints; obtaining answers to all types of questions and clarifying their doubts. As a consequence, the senior citizens will be able to put into operation communication processes in an appropriate manner; carry out different types of job duties and responsibilities in an efficient manner; promote their health conditions, both from physical as well as psychological perspectives and lead to up-gradation of one's overall standards of living. Therefore, it can be stated, being overwhelmed by loneliness and seclusion is an adverse cause enabling senior citizens to live in old age homes.
